- **5. POLICE DEPARTMENT BUDGET –** The fiscal year just began so there is nothing to report yet on budget.
- 6. POLICE DEPARTMENT ACTIVITY & UPDATE Chief Murray distributed the Police Department Activity for the Month of April 2023. Attorney Sosnowski has been in touch with Officer Woolbright after he left the department. He will make a training reimbursement payment this week and when he receives payment from IMRF. Attorney Sosnowski is drafting a reimbursement agreement for the remainder of the amount owed. Officer Hankins is ahead of schedule on his field training. Chief Murray has placed ads in the local papers and on a law enforcement website and has received six requests for applications. One potential candidate has police training. He has had several inquiries about wages. He discovered that the top of our patrolman schedule is less than the starting pay for Officer Woolbright in Crystal Lake. Several close-by communities also pay the same

or close to the same as Crystal Lake. Chief Murray stated that many police departments are looking for officers to move in laterally from other departments. Alderman Hanlin added that we need to stay competitive with our wages. Attorney Szeto stated that we will go into executive session tonight to hear a report of the first FOP negotiation meeting.
