- 6. POLICE DEPARTMENT ACTIVITY & UPDATE Chief Murray distributed the June report. There were no incidents at ByronFest. He had good support from the sheriff's office, both with on and off duty officers. Chief Murray believes that it helps not having the bars open for an hour after the festival.

National Night Out will be held August 1. The event is located on Washington St. and is held in conjunction with the Sheriff's Department and the Fire Department. The Hib Reber Car Show winners will be on display.

Chief Murray has received six applications for a new police officer. One has part time academy training and has an associate degree. He currently works part time in one of the Chicago suburbs and recently moved to Stillman with his family. Chief Murray has started a background check and has scheduled a psych test next week.

- A large presence of Police and Fire were at the Fire Department and the School this morning. They are having rapid deployment training July 19 and 20.
- 7. SOCIAL MEDIA Clerk Huber reported that we have been trying to be as informative as we can about the construction going on around town. Chief Murray added that the department is looking for crossing guards and will send information to post on Facebook.
