PEDDLER'S PERMIT

Peddler - Any person who offers for sale any merchandise, article or thing adjacent to the streets or sidewalks whether on public or private property.

Requirements:

- a. Fill out the application
- b. Present Driver's License or ID card with photo to staff
- c. Submit to a criminal background and reference check
- d. Provide proof of liability insurance with at least \$500,000 in coverage, with a certificate verifying that the City is named as an additional insured
- e. If using a vehicle in the course of the activity as a peddler, provide proof of automobile insurance on said vehicle with at least \$500,000 in bodily injury coverage limits.
- f. Make payment
