MINUTES OF THE COMMUNITY SERVICES COMMITTEE  
WEDNESDAY, MARCH 4, 2020, 5:30 PM  
BYRON CITY HALL**

Alderman Fulrath called the meeting to order at 5:55 pm.

1. **PUBLIC COMMENT** – None
2. **APPROVAL OF MINUTES FEBRUARY 19, 2020, SPECIAL MEETING** – Alderman Gerdes motioned to approve the minutes of February 19, 2019, as presented. Seconded by Alderman Gyorkos. Motion passed.
3. **TSC MILL ROAD TEST RESULTS** – Engineer Stoll received the reports from TSC late today. Ground water levels do not appear to be a reason for the street settling. The ground water table was 24-1/2' below the surface. They dug in 4 locations. The granular trench backfill used around the sanitary sewer was in a loose to medium dense state. The pavement settlement may be a result of this. Engineer Stoll questioned whether there is a hole in the sanitary sewer line that would cause the materials to enter the pipe. There was no material in the manholes, but he recommends that we look at the pipe with a camera to be certain. More investigation needs to be done before we proceed with fixing the road.
4. **2020 STREETS PROGRAM** – Engineer Stoll reported that they are working on the bid documents, however, they will hold off on Mill Road until decisions are made. He hopes to have bids back in April.
5. **STREET SWEEPER PURCHASE** – Director Vincer was absent, but provided information regarding the street sweeper he wishes to purchase, along with loan information from Byron Bank. The purchase of the street sweeper was approved at the last committee meeting.
6. **ENGIE-WATER TREATMENT PLANT** – ENGIE will make a presentation to Council in April.
7. **PUBLIC WORKS UPDATE** – Director Vincer provided an operations report which is included in Dropbox. He updated the committee on the street sweeper purchase, hiring part time summer help, and planned summer projects.
8. **EXECUTIVE SESSION (Section)(c)(21)-Review and Approval of Closed Meeting Minutes.** No Executive Session.

9. Alderman Fulrath adjourned the meeting at 6:13 pm. The next regular Community Services meeting is April 1, 2020.
