CITY OF BYRON, ILLINOIS APPLICATION FOR ANNUAL PERMIT UTILITY TERRAIN VEHICLES

Pursuant to Title 10, Chapter 18 of the City of Byron, Illinois Code of Ordinances, certain Utility Terrain Vehicles (UTV) may be approved for use on specified streets, roadways and alleys of the City where the posted speed limit is 35 miles per hour or less. UTV's may not be used on any toll road, interstate highway, controlled access highway or other highway or road under the jurisdiction of the State of Illinois, County of Ogle or ______Township. Utility Terrain Vehicles means:

A commercially designed and manufactured motorized off-highway device designed primarily for off-highway travel, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less for gas-powered engines or 3,000 pounds or less for electric-powered engines, traveling on 4 or more non-highway tires, a steering wheel for steering control, and designed with non-straddle seating that confirm to applicable federal regulations (see Title 49 C.F.R. part 571.500). UTV shall not include equipment such as lawnmowers.

Applicants shall be required to comply in all respects with Title 10 Chapter 18 of the City of Byron Code of Ordinances and the Illinois Motor Vehicle Code, including the obligation to purchase an annual permit from the City. Violations may result in suspension or revocation of the permit and significant fines and other penalties.
